Many organisations can encounter frustrations and difficulties in this area – GIRL 2 demystifies legal issues faced by those running community organisations, providing practical guidance and minimising technical legal content.

The new and fully revised editions of GIRL 1 and 2 expand on key elements of the original documents, reflect changes to Company and Charity Law and have been made applicable to all community organisations, not just play and childcare. Updated constitutions, case studies from a range of community organisations, relevant signposting and other improvements provide clarity and ease of use for the reader.
